## EVENT & NOTIFICATION MONITOR

Software application for Servers, PCs, Tablet and Smartphones developed to enable the CPS management software to communicate immediately with numerous fixed and mobile devices. The CPS monitor does not simply display alarms and images. Its functionality also extends to on-site verification (click and ready) by cross checking information from other databases to make the checks carried out by the Police in the field efficient and effective.



## ■ HOW IT WORKS

CPS Monitor is a software application developed as an App for mobile Android devices (Smartphones and Tablets) and as a Windows program for portable and desktop PCs. CPS monitor works exclusively in conjunction with the CPS software installed at the Headquarters.

## ■ WHAT IT DOES

The CPS monitor allows you to:

- ▶ Carry out checks on vehicles by consulting the CPS system database at the operations centre.
- ▶ Receive notifications regarding uninsured vehicles and vehicles without a roadworthiness certificate.
- ▶ Receive notifications about vehicles that have been reported stolen, under investigation, included in the black list or in the CPS lists at the operations centre.
- ▶ Receive alerts, both as an image and vocal (speech to text), about the type of notification and the number plate. This is very useful for public safety personnel on the move, where sunlight reflected onto the display often prevents the image of a stolen vehicle from being viewed clearly or directly.
- ▶ Easily identify the notifications received due to a different colour being associated with each type of alert.
- ▶ Display the connection status of the VPN, of the Tablet with the server, the connection between the cameras and the operations centre server.
- ▶ Display the details of the notification together with all associated data.
- ▶ Signal a "false alarm" to the server.
- ▶ connects directly to databases to carry out searches for insurance / roadworthiness certificate / previous owners in the Ministry of transport, Ministry of Interior databases or lists integrated in the operations centre CPS.

### What ISDP10003: 2018 means
